Our goal is to bring long-term and comprehensive help for victims of the war in Ukraine, who find their selves in Poland because of Russia's invasion. We are renting apartments for a period of 1 year for single mothers or whole families, victims of the war. From legal perspective, IFL Polska is a "foundation" based on document called "STATUS FUNDACJI". One of legal goal is bringing charity help and caring social help for families, individuals in difficulties. Also bringing help for victims of a war in our country and even abroad.

We would like to give thanks to all of you who decided to trust us and join our project of practical help for refugees. In July 2022, with your help, we have collected **224 071,62 PLN** (47.059,04 US Dollars¹ or 68.320,77 Australian Dollar² or 47.119,41 EUR³).

With your help we are able to rent 10 apartments, which means that we brought shelter for a period of 1 year for 10 families with children (about 25 individuals). What is more:

- Financial help in renovation 2 houses in Ukraine,
- Financial help in leg amputation surgery for individual in Ukraine,
- Transportation for refugees in Poland
